## **APPLICATION FOR STORMWATER PERMIT FEE SCHEDULE**

<b><u>DEVELOPMENT ACREAGE</u></b>	<b><u>FEE</u></b>
<b>Less than 10.0 acres<sup>1</sup></b>	<b>\$2,000.00</b>
<b>10.0 to 49.9 acres<sup>1</sup></b>	<b>\$3,500.00</b>
<b>50.0 acres and greater<sup>2</sup></b>	<b>\$3, 500.00 base fee, plus \$20.00 per acre over 50 acres<sup>3</sup></b>

1. Development Acreage includes the entire site.
2. Development Acreage includes only the area to be physically built or impacted by construction activities. Undeveloped portions of the property will not be counted in determining the affected acreage. Refer to Section 2.00.00 of the St. Lucie County Land Development Code for definition of the term “development”.
3. Example: 100 acres = \$3,500.00 + (50 acres \*\$20.00) = \$4,500.00.

Stormwater permits include all construction plan reviews, inspections and final record drawing reviews. In accordance with Land Development Code Section 11.05.07.B., the Stormwater Permit application shall include following information:

1. Name, address and telephone number of the property owner, the applicant (if different from owner) and project engineer, consultant or agent.
2. Detailed location sketch with section, township and range.
3. Recent aerial photograph with the project boundaries shown, north arrow and scale indicator.
4. Topographic map of the presently existing project site. The map should contain, at a minimum: the project boundaries, a north arrow, a scale indicator, one-foot contour lines which extend at least ten (10) feet beyond the project in all directions, and bench mark information (NGVD).
5. Boundary survey and legal description.
6. Soil boring to a minimum depth of six (6) feet below average existing ground elevation identifying soil types and seasonal water table fluctuations.
7. Detailed paving, grading and drainage plans identifying all storm water management structures and facilities.
8. All drainage calculations and supporting documentation used for the design of the stormwater management system as outlined in Section 7.07.00 of the Land Development Code.
9. Legal positive outfall shall be documented if applicable.
10. All information submitted to the SFWMD that was the basis for issuance of its permit or letter of exemption, where applicable.
11. Please refer to Section 1-7.7 of chapter 1-7 of the Code of Ordinances of St. Lucie County, Florida for additional requirements concerning the National Pollutant Discharge Elimination System (NPDES) for activities involving land disturbance activities over 1.0 acre.
